COMPETITION POINTS

- 1. Each varsity team/individual is limited to 32 competition points prior to the regional tournament. Each subvarsity team/individual is limited to 28 competition points prior to the regional tournament.
- 2. Competition points for events are listed under bylaw 7.24.1.D of the NMAA Wrestling Bylaws.
 - a. Non-District Events
 - 1. Single Dual 1 point
 - 2. Two Duals (Triangular/Double Dual) 2 points
 - 3. One-Day Event (3-6 Duals or Individual Tournament) 3 points
 - 4. Two-Day Tournament with single or double elimination 4 points
 - 5. Two-Day Tournament with no/limited elimination 6 points
 - b. District Duals
 - 1. District Duals (6 or fewer schools) 3 points
 - 2. District Duals (7-8 schools) 4 points
 - 3. District Duals (9+ schools) 5 points
 - Q1: If my school attends a two-day event that includes a combination of dual meets and individual competition, how many points am I assessed?
 - A1: Because there is limited elimination in this competition format, schools are assessed 6 points.
 - Q2: If I attend a two-day tournament (dual or individual) that is not double elimination, how many points is my school assessed?
 - A2: Because there is limited elimination in this competition format, schools are assessed 6 points.
- 3. Each middle school/junior high team/individual is limited to eight (8) meets.
- **4.** For individual limits, all events non-NMAA, sub-varsity, including MS/JH, and varsity) count towards an individual's event limits. When the total number of competition points at all levels reaches 28, the individual is no longer eligible for sub-varsity competition. When the total number of competition points reaches 32, the individual is no longer eligible for further regular season varsity competition.
 - Q3: Do non-scholastic events count against individual competition limits during the defined NMAA wrestling season?
 - A3: Yes. Once the official high school season begins, all meets, scholastic and non-scholastic, count toward the overall competition limit.

- **5.** 8th grade students that opt to participate at the high school level, shall be assessed the high school equivalent for each meet wrestled at the middle school/junior high level.
 - Q4: An 8th grade wrestler competed in six (6) NMAA middle school events before being moved up to the high school level. He competed in three (3) single dual meets, two (2) one-day individual tournaments and (1) dual meet quad. What are the equivalent high school points he has used?
 - A4: 12 points. Three (3) single duals (1+1+1) = 3 points. Two (2) one-day tournaments = (3+3) 6 points. One (1) dual meet quad = 3 points.

DISTRICT DUAL MEETS (BOYS ONLY)

- 1. Schools shall compete in a dual meet against each school in their district to be eligible for post-season participation.
- 2. Varsity teams shall be assessed a flat point value which correlates to the number of schools in the district (see 7.24.1.D). Schools shall subtract these points from the 32-point varsity limit and the remaining points shall be used to complete the rest of the varsity regular season schedule.
 - Q5: There are 8 schools in my district. How many points am I charged for wrestling each team in my district in a dual meet and how many points do I have remaining to complete my schedule.
 - A5: Your school is charged 4 points for your district duals, and you have 28 points remaining to complete the rest of your schedule.
- **3.** Districts/schools have the option to schedule their district dual meets using any of the standard formats available and will only be assessed the flat point value.
 - Q6: There are 6 schools in my district. If I wrestle each district opponent on individual dates, how many points is my team assessed?
 - A6: Your school is assessed 3 points. Schools are assessed points for district duals based only on the number of schools in the district.
 - Q7: There are 8 schools in my district. I would like to wrestle 5 schools on one date and wrestle the other two schools on individual dates. How many points is my team assessed?
 - A7: Your school is assessed 4 points. Schools are assessed points for district duals based only on the number of schools in the district.
- 4. Individuals shall be assessed points only for those district duals wrestled, not to exceed the flat point value.
 - Q8: There are 6 schools in my district. My 139-pound wrestler only wrestled in two (2) district dual meets. How many competition points is he assessed?
 - A8: While the team is charged 3 points, the individual is only assessed points for those matches wrestled. Since he only wrestled in two district dual meets, he is only assessed 2 points.

- Q9: There are 9 schools in my district. My 172-pound wrestler wrestled in 7 district dual meets. How many competition points is he assessed?
- A9: Both the team and the individual are charged 5 points. An individual cannot be charged more than the flat point team value.
- Q10: There are 6 schools in my district. My school wrestled two schools on Date #1 and three schools on Date #2. My 189-pounder missed Date #1 but wrestled all three schools on Date #2. How many competition points is he assessed?
- A10: Both the team and the individual are charged 3 points. Even though the individual missed two duals on Date #1, he is assessed points individually for the 3 matches he wrestled on Date #2.
- 5. District dual meets shall be scheduled in advance and designated as a district dual meet.
 - Q11: If I happen to run into a district opponent during a dual meet tournament, can I count that dual meet toward the district dual meet requirement.
 - A11: No. District dual meets must be scheduled in advance and designated on your schedule.
- **6.** Schools that opt to add non-district teams to a district dual event, will be charged points separately for each non-district team wrestled.
 - Q12: I plan to wrestle a quad which includes 2 district schools and 1 non-district school. How many points for non-district competition is my school assessed for this date?
 - A12: 1 point.
 - Q13: Our district has 4 schools. We would like to wrestle all district duals on one date and include two non-district schools as well to create a 6-team round robin event. How many points is my school assessed for this date?
 - A13: 5 points. 3 points for completing the district dual requirement and 2 points for each non-district school wrestled that date.
- 7. Schools that opt to wrestle a district team during a dual meet tournament, will still be charged the full point value for that event.
 - Q14: My district has 8 schools. During a two-day dual meet event with no elimination, my school is scheduled to wrestle 8 dual matches. I plan to wrestle two district schools during the event and want to count those matches toward the district dual meet requirement. How many points for non-district competition is my school assessed for this event?
 - A14: Your school is assessed the full value for the event 6 points.
- **8.** One-day events that take place during the school week may not begin until 3:00pm.
- 9. No competitions may take place the week of the regional tournament, including any district dual meets.

- **10.** Girls and sub-varsity boys' teams that opt to wrestle district duals, shall be assessed points only for those duals wrestled, not to exceed the flat point value.
 - Q15: I have 6 schools in my district but only opt to wrestle 2 district duals with my girls' team. How many points is my team assessed for those matches?
 - A15: Your school is assessed 2 points, one for each dual wrestled.
 - Q16: I have 8 schools in my district but only opt to wrestle 5 district duals with my JV boys' team. How many points is my team assessed for this event?
 - A16: Your school is assessed 4 points, because that is the maximum value for district duals in a district with 7-8 schools.
