DISTRICT INDIVIDUAL TENNIS TOURNAMENT GUIDELINES - 2025



SCHEDULE/ENTRIES

- 1. Specific information will come from the district chair/tournament host.
- 2. Teams shall submit their official entries via the <u>District Individual Tournament Entry Form</u> no later than **12:00PM Wednesday** (**April 30, 2025**) the week of the district tournament.
- 3. Teams failing to submit their entries by the deadline shall be subject to a fine.
- 4. Singles/doubles entries per school shall be determined by each district but shall not exceed four (4).
- 5. Players may only enter singles or doubles competition, not both
- 6. Entries shall not be changed after rosters are released; however, teams may replace a player who is forced to withdraw after the submission deadline. All players must be listed on the team line-up submitted Week #42 and replacement players may not shift from singles to doubles or doubles to singles to fill a withdrawing player's spot.

EVENT PLANNING

- 1. The district tournament is to be held in week #44, April 28 May 3, 2025.
- 2. The district tournament does not count against the NMAA event limit.
- 3. In combined districts, the district chairs should work together to establish the host site.
- 4. Format for the district tournament should be consistent with the state tournament single elimination, semifinal losers play for 3rd place, no 5th place match, etc.
- 5. Seeding procedures should be consistent with those used for the state tournament. Top six (6) entries seeded with the following criteria considered head-to-head, common opponent, returning state place, overall record. Remaining entries are drawn randomly.
- 6. Match scoring is best two-of-three tie-breaker sets, with ad scoring and a 7-point tiebreaker at 6-all in each set.
- 7. Top three (3) placing singles/doubles entries automatically qualify to the state tournament.
- 8. Singles/Doubles entries must complete their semifinals matches to be eligible for the 3rd place match.
- 9. It is the discretion of the district to charge admission; if admission is charged; max price is set at \$12.
- 10. Districts may consider hiring a registered USTA Official to oversee playing rules.

REPORTING DEADLINES

- 1. <u>District Placement Form</u> To be submitted by the **district chair** or designee by **8:00PM**, **Saturday**, **May 3**, **2025**.
- 2. Coach Input Form To be submitted by coaches by 9:00AM, Sunday, May 4, 2025.

DISTRICT MEETINGS

- 1. State singles and doubles seeding will be conducted by a committee comprised of district team champion head coaches.
- 2. District coaches should meet prior to or after the district tournament to review their entries' matches and records against competition from other districts.
- 3. District team champion head coaches should be prepared to serve on the state seeding committee the day after the district tournament to represent their district's individual placers.
