NMAA member schools may apply for monetary assistance in the form of a NMAA Foundation Grant by completing this application packet; due date is the last day of April. Funding will be allocated as deemed appropriate by the NMAA Foundation Board of Directors.

A school may apply for one of three grants

- 1. Program Start-Up Grant:** This grant will be awarded to a NMAA member school to assist in the start-up costs of a new athletic or activity program. A school applying for this grant must receive emergency funding from the NMPED. Grants will be allocated as deemed appropriate by the NMAA Foundation Board of Directors. Complete Parts A, B and D of the attached packet.
- 2. Supplemental/Matching Grant:** This grant will be awarded to a NMAA member school with the goal of supplementing/matching the amount that the school has committed to the start of a new athletic or activity program. A school applying for this grant should not be receiving emergency funding from the NMPED. Grants will be allocated as deemed appropriate by the NMAA Foundation Board of Directors. Complete Parts A-D of the attached packet.
- 3. Other:** If you feel that the financial needs of the school and/or program are not addressed by the grants above, and the needs meet the goals of the NMAA Foundation, please complete Parts A, B and D of the attached packet. Grants will be allocated as deemed appropriate by the NMAA Foundation Board of Directors.
