THANK YOU for your willingness to judge/officiate NMAA Powerlifting!! This is an exciting opportunity to expand Powerlifting in the State of New Mexico. This year the NMAA will host one State Sanctioned Meet (State Championship) in April with the goal of expanding regular season sanctioned meets across the state in 2023. Below is what being a State Championship Powerlifting Judge entails for the 2022 season. *The 2022 rule book can be found and downloaded at https://www.nmact.org/activities-powerlifting/

- > Become a Certified NMAA Powerlifting Judge (instructions for registration located on page 2)
 - Requirements
 - ✓ Certification/registration through NMAA Officiating Services
 - Certification/registration fee is waived for the 2022 Powerlifting season
 - ✓ Complete the 50-question rule book exam (offered within your registration) (instructions on how to access and take exam on page 2)
 - ✓ Attend the Pre-State Judges Meeting (date will be announced as we approach the State Meet)
- Each Official that works the State Meet will be paid \$120.00 for the meet.

STATE MEET ASSIGNMENTS

Judges' assignments at the State Meet will be as follows

The NMAA will run Four Racks at the 2022 State Powerlifting Championships

- Judges Per Rack: 3
 - Chief Judge/Side Judge/Side Judge
 - Can rotate within the rack at the Chief Judges Discretion
- Head Meet Judge: 1
 - Responsible for overseeing judging protocols and ensuring a fair and high-quality meet
- Alternates: 2
 - Responsible for giving judges breaks as needed and ensuring a continuous flow of the meet.

REGISTRATION AND EXAM INTRUCTIONS

STEP 1

- >Create a DragonFly account at https://www.dragonflymax.com/
- >Select the "Official" icon
- >Select the "Contest Official" icon
- >Select "New Mexico"
- >Join NMAA | New Mexico Activities Association
- >Select the "Powerlifting" Icon
- >Skip the local association
- >Review your information and then save
 - >Update the demographics to be complete with your profile set up

STEP 2 (Exam Registration)

- The 2022 Rule Book exam is in your DragonFly account under eligibility requirements
- > Take the 50 question Rule Book Test
 - A passing score of 70% or higher is required to pass the exam.
- Your score will be reflected in your DragonFly account with a "Ready" icon

You can now be assigned to the NMAA State Powerlifting Meet!!
