Football: Film Submission

Update Bylaw 7.15.1.M – Film Requirement to include a progression penalty for weekly game film not turned in on time.

- Thursday games – film must be submitted by 1:00 p.m. on Saturday
- Friday games – film must be submitted by 1:00 p.m. on Saturday
- Saturday games – film must be submitted by 10:00 a.m. on Sunday

Film not received in the NMAA/NMOA Hudl account using the above deadline will now be subject to penalty as follows:

- 1st Offense – Warning in Writing to Head Coach and Athletic Director
- 2nd Offense – Suspension from the 1st Half of the next game for the Head Coach
- 3rd Offense – Suspension from the entire next game for the Head Coach

Rationale: The current deadlines have become more like suggested deadlines. Coaches are holding film, with the excuse that their next opponent has an advantage. The penalty progression will put some consequences to the bylaw. The Football Sports Specific Committee was unanimously in favor of this, citing that late film has become more of an issue in recent years.

Soccer: Misconduct Progression

To align with National standards, the soccer committee with support from member coach survey data, is recommending removing card count misconduct progression for players and coaches from our bylaws entirely. Ejection penalties would still exist in alignment with all other sports.

Modify Rule 7.17.3 – Misconduct Progression Rule

Regular season – remove sections 1-3 referring to card counts during the regular season for teams and individuals. Sections 4a,b,c and 5 specific to ejections would remain.

Rationale: There is a feeling nationally that this is an outdated rule. 32 states do not count cards. Only 4 states count team cards. 14 states have individual counts, typically around 5, and several are considering removing these policies. Other sports do not track the number of fouls (i.e.: we do not count technical fouls in basketball or UNC's in football). Ejections for red cards (including a "second yellow") would still result in a suspension for the next scheduled game. Eliminates excessive game reports for officials to only include reports for ejections.

Soccer: Regular Season Overtime

To align with National standards, the soccer committee with support from member coach survey data, is recommending removing overtime during the regular season, except when a regular season tournament requires declaring a winner for advancement.

Rationale:

Player safety - Potential for injury with increased minutes, i.e.: multiple OTs in the same week - if 3 games in a week all go to OT, additional 60 minutes of play.

National consistency - OT periods are by state adoption only. 41 states do not play overtime in the regular season (player safety is cited as the #1 reason). All other national governing bodies end regular season games in ties.

Facility constraints - Fields without lights and/or later start times have trouble finishing and sometimes eliminate the JV game to follow, especially later in the season.

Rewarding regulation wins and regulation ties - Ties are part of the sport and factored into MP rankings. A regulation win earns more than a tie, likewise a loss in overtime is not rewarded for playing an evenly matched regulation 80 minutes.
