PERSONAL INFORMATION RELEASE AND AFFIDAVIT OF CRIMINAL CONVICTION

During the September 27, 2006 meeting of the New Mexico Activities Association Board of Directors, a rule was passed which requires individuals registered with the New Mexico Officials Association to be subject to background checks in order to be a member of the Association. (Note: This rule was passed by the NMOA Executive Board at their meeting on July 27, 2006.) The NMAA Board of Directors determined that the NMOA would initially perform background checks on all officials who registered for the first time during the past four school years, in order to mirror the policy in place for educators in our state. Any official who submitted his/her first registration during the 2005-2006 school year or in any of the subsequent years and is still active with the NMOA is subject to a background check to be performed by the NMAA office.

Due to the policy as stated above, all officials must complete the following Affidavit of Criminal Conviction and Personal Information Release each year, even if you have completed one in a previous year. Although we are initially doing background checks on new officials from 2005-2006 until the present year, background checks may be performed on any and all members of the NMOA.

I understand that any omission/untruthfulness in the disclosure of a criminal conviction or any other information on this registration form is grounds for the immediate revocation as an NMAA/NMOA official and future ineligibility for registration. In addition, conviction of a crime does not necessarily disqualify me as a member of the NMOA. Each conviction will be reviewed by the NMOA Supervisory Committee on a case-by-case basis.
