Enclosed please find a registration form for the 2009 NMAA/NMOA Alternate State Clinic. We will be hosting two Alternate Clinics this year, due to the cancellation of last year's Alternate Clinic. This year's clinics will take place on Sunday, October 18, 2009 at Piedra Vista High School in Farmington and at New Mexico Junior College in Hobbs.

The registration fee for the Alternate State Clinic is \$50 for unlimited sports. The deadline for pre-registration is **Friday, October 9, 2009**. Any registration forms received after this deadline will be subject to a \$10 late fee. On-site registration will be \$60.

**IMPORTANT NOTE:** Due to the minimal interest in the Alternate State Clinic over the past several years, we require a minimum of six pre-registrants in each sport offered to hold these clinics. If the minimum number does not register for these clinics by the pre-registration deadline, the clinics will be cancelled and any pre-registered officials will receive a full refund of their dues. The decision to cancel the clinic will be made by October 12, 2009 and anyone who has pre-registered will be notified by telephone if the clinic is cancelled.

**Please do not rely on other people to register for the event for the clinic to take place!!!!** Last year, numerous officials called our office after the decision was made to cancel the event stating that they were going to register on-site and were trusting that six other officials would register for it. If you need this clinic attendance, please pre-register to ensure we will hold the event.
