## ***EACH CANDIDATE MUST MEET THE FOLLOWING REQUIREMENTS:***

- Candidate for **recognition** must be a student, adult, team, high school, junior high or spirit group who has exhibited true sportsmanship by Pursuing Victory With Honor.
- Candidate for **monetary scholarship disbursement** must be a graduating senior who has exhibited true sportsmanship by Pursuing Victory With Honor.
- **APPLICANTS** must submit a one page personal statement addressing the importance of sportsmanship and its relevance in interscholastic activities and life.
- **NOMINATORS** must submit a one page statement addressing the candidate's worthiness of this award.
- A recent photograph or clear snapshot (wallet size) of the candidate must be submitted.
- At least three letters of recommendation.

## ***TIPS ON COMPLETING THE APPLICATION/NOMINATION PACKET***

1. Read the requirements listed to the left carefully
2. Be sure to fill out the application/nomination form completely.
3. Applications/nominations must be received in the NMAA office **NO LATER THAN February 12, 2010.**
4. Mail all materials together to insure that all information is received.
5. Incomplete application/nomination packets will not be considered.
