- SAEA Revise/Amend Updates
  - -Compliance information/education SAEA/Title IX NMADA members Scott Evans solicited input and ideas from all board members as information and needs arise
  - -Communications with NMPED, offer to assist in development, June availability preference e-mails appear to indicate the report format is not yet available Scott to share Michael Archibeque e-mail with board members for the purpose of contacting (need for availability soon).
  - -Pursuing legislative revision sunset/repeal conversation with another female senator (Lisa Torraco) indicate current political reality is sunset/repeal not likely to pass
  - -Pursuing legislative revisions other provide some relief to athletic directors, change momentum -Communications with SWLC engaging SWLC (in conjunction with state legislators) with regard to revisions of the law to lessen the burden on school athletic directors may also provide a forum for some informal communications on other aspects of SAEA (reports, compliance, etc.)
  - -Consensus that we pursue "relief" with state senators Gay Kernan and Lisa Torraco and engage SWLC with their assistance/participation

- NMADA Scholar-Athlete Awards NCAA Scholarship Limits discussion regarding award of NMADA scholarship dollars to recipients who might be receiving other grants-in-aid, especially those that might be "full" scholarships. Recommendation to continue case by case basis as in the past. Specific action was taken to grant an extension to Brenna Freeze, the 2007-08 female Scholar-Athlete Award winner whose scholarship was held/guaranteed to July 1, 2012 (M-C.Henderson, 2<sup>nd</sup>-M.Huston, Approved)
- NMADA AD of the Year Awards Nominations Scott announced names/schools of those nominated thus far, plenty of nominees for rookie and large school, may need some small school additions

- Finance policies attached approval for standing policy (M-L.Waters, 2<sup>nd</sup> B. Shea, Approved)
- Door prize(s) for general meetings (other than Fall Conference) A variety of prizes from a variety of sources (from donations to small gift cards) to be used to foster attendance/participation
- Policies, Operations, Procedures (POP) Manual updated/distributed annually July Board Meeting
- Leadership Council Topics/Discussion Meeting to be held on Wednesday, 22<sup>nd</sup>, current topics include C&A "final" ASAP after 40 days (scheduling) and game limits (reduce 2 games basketball, baseball/softball), Ernie Viramontes may have additional, Vicki Nelms may have additional
