- 5. New Business
 - SAEA/Title IX NMAA Gary Tripp quick review of LESC work and input of groups to get some acceptable adjustments/relief with SAEA HB 161, some discussion of other changes moving forward, working jointly
 - SAEA/HB 161 Update Bill Cleland gave some direction on specific changes to SAEA as provided by HB 161, passed by legislature, signed by governor
 - SAEA Compliance Manual Report Brian Shea, RISD gave names of NMADA reps, gave a description of the content of the manual 6 chapters
 - SAEA NMADA Going Forward Cooper Henderson review of legislative input process, encourage membership and board to continue to work on options including repeal, AD's could/should influence legislation that directly affects us



- NMADA Input for NMAA Scott Evans suggested that NMADA look at doing membership surveys and submitting for formal input to NMAA staff on topics/issues of importance (e.g. 2 week moratorium, event limits, etc.) promote NMADA membership, true picture from AD perspective, take pressure off NMAA staff
- MS/JH Initiatives/Timing Scott Evans suggestion that board and membership look at expanding the involvement of MS/JH as their membership expands Awards, Board, Fall Conference breakouts, etc.
- Coaches and AD Education, Licensure, Training Update Scott Evans A licensure and professional development discussion group including NMAA, NMADA, NMHSCA, NMPED, UNM has been meeting initial indication that AD's may be able to formally evaluate coaching personnel without an administrative license (more to come on that) which would indicate no immediate need for an A.D. specific licensure; discussion still going on regarding how much to add and when regarding update of coaching licensure personal opinion (Scott Evans) that in light of national standards (about 40% of states require CPR, about 60% require FA) and costs, NFHS Health, Safety, and First Aid course be added as a one time requirement as is NFHS FOC and that "current" CPR/AED and first responder FA be done by local schools/districts based upon needs and resources a show of hands indicated a strong preference that the new NFHS course requirement be added for a level 1 license rather than waiting for level 2 (Temporary/1 year still available).
- "nfhslearn.com" Scott Evans A copy of current courses available from the website/program attached with costs encourage AD's to use as tools for PDP's in conjunction with evaluation of coaches NMADA receives a \$1.00 royalty for every course (other than FOC and FA), currently about \$75.00/quarter.
- Leadership Council Topics (meeting May 23 12:00-2:000pm) Vicki Nelms Possibility of transfer of code(s) of conduct consequences following students who transfer schools (from LOA workshops)
- Classification and Alignment Robert Zayas discussed some of the basic principles under consideration including enrollment figures, the number and size of classifications, possible multiplier for private schools, etc., plan to be submitted to the NMAA Board at June meeting.
