### Action Items as Needed:

Reassess the postponement of state spirit and suspension of spring sports and winter/spring activities based on announcements made by the Governor's Office, Public Education Department, and Department of Health – Based on the Public Education Department's and Governor Michelle Lujan Grisham's announcement that schools would be closed for the remainder of the 2019-2020 academic year, Mr. Dempsey made a motion to cancel State Spirit, Spring Sports, and all Activities. This would include practice, in addition to contests/events. Ms. Sanders seconded the motion. A vote was taken and passed unanimously (13-0).

### **Discussion Items:**

Scholastic Eligibility: 2020-2021 School Year - Ms. Sally Marquez, NMAA Executive Director, stated that the NMAA will be looking to implement temporary guidelines to determine scholastic eligibility for the 2020 Fall Semester based on the current situation and possibility that many school districts will be using Pass/Fail grades. She mentioned that many other state associations across the nation are looking to do the same.

Out of Season Coaching/Summer Regulations - Ms. Marquez stated that the NMAA will need to reassess its summer regulations pertaining to coaching based on guidance from the Governor's Office and public health officials in the coming weeks. The Board of Directors will meet in early May to discuss possible scenarios based on the ever-evolving COVID-19 public health threat.

### **Consider Adjournment:**

Mr. Parks asked for a motion to adjourn the meeting at 12:46 p.m. Ms. Sanders made the motion to adjourn the meeting. Mr. Carpenter seconded the motion. A vote was taken and passed unanimously (13-0).
