



CRITERIA FOR INDUCTION INTO THE NMOA HALL OF FAME



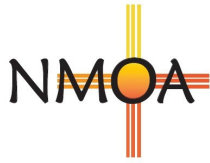
This award is sponsored by the New Mexico Officials Association and selected through the Hall of Fame Committee.

The NMOA Hall of Fame Committee considers for induction to the NMOA Hall of Fame individuals who have made significant contributions to interscholastic officiating in our state. The criteria are as follows:

- 1) Retired nominees must have a minimum of fifteen (15) years of service to the New Mexico Officials Association in one capacity or another and must be in good standing with the Association. Active nominees must have a minimum of twenty-five (25) years of service to the New Mexico Officials Association in one capacity or another and must be in good standing with the Association.
- 2) Nominations must be initially submitted to the NMAA Commissioner of Officials by May 1st of each year. If a nominator has not supplied enough information to the committee for a particular nominee, the committee will notify the nominator of the deficiency and the final deadline for submission will be June 1st of each year.
- 3) The New Mexico Officials Association President and the NMAA Commissioner of Officials appoint a committee to evaluate and select a person or persons to be inducted into the Hall of Fame. The chairperson of the Hall of Fame committee is the NMOA Vice-President.
 - a) In addition to the NMOA President and Vice-President, there must be two additional members of the NMOA Executive Board appointed to the committee by the President and Commissioner of Officials, as well as a current Hall of Fame member, also appointed by the Commissioner of Officials and NMOA President.
 - b) The committee should have representation from all areas of the state.
 - c) In the case that both the NMOA President and Vice-President are voted out of their positions, one of them must stay on the Hall of Fame Committee for the next two-year block to ensure continuity in the selection process and for historical reference.
 - d) The NMAA Commissioner of Officials and Assistant to the Commissioner of Officials are non-voting members of the committee and serve only for administrative purposes.
- 4) Award presentation and recognition is during the annual meeting held annually in July.
- 5) The Hall of Fame Committee will induct no more than three inductees per year. Additional inductees may be considered in extraordinary circumstances, at the discretion of the committee.

NOMINATION PROCESS:

- 1) To nominate an individual, the nominator must obtain and utilize the form provided through the NMOA. Information which is important, in addition to those items required in that document, should reflect those significant accomplishments to the organization, contributions, service to the NMOA both on and off the playing field and devotion to officiating as exhibited in one form or another. The nomination should include information relevant to officiating at the high school level and should highlight their achievements above and beyond years of service (i.e., mentoring, training, evaluating, leadership roles at the state and local levels, etc.).
- 2) Additional information, including three letters of recommendation and a resume must be included for review by the committee. The letters of recommendation must pertain to the nominee's NMOA contributions.
- 3) Nomination forms and supplemental information may be submitted to the NMOA at any time, but the application must be received by June 1st for consideration in the current year.
- 4) The inductee must provide a photograph to put in the NMOA Hall of Fame in the Hall of Pride and Honor at the New Mexico Activities Association office.
- 5) Individuals who are nominated but not inducted into the Hall of Fame will have their nominations retained by the committee for up to three years. The nomination can be reactivated for consideration by completing the NMOA Hall of Fame resubmission form.
