#### **NMAA Director's Report:**

Ms. Sally Marquez, NMAA Executive Director, presented the Director's report. She discussed (5) items on her report: 1) provided information on the recent Board of Directors elections - Mr. Lee White and Mr. Travis Dempsey were re-elected & Mr. Daniel Benavidez was elected to take over for Mr. Kirk Carpenter; 2) thanked Mr. Carpenter for his service on the Board of Directors and his dedication to the students of New Mexico; 3) stated that the NMAA's newest activity of Powerlifting has started competitions with nearly three hundred students participating; 4) provided an update on the NMAA Foundation that included information regarding the decision to increase student scholarships by \$20,000 (\$45,000 total) for the 2020-2021 school year; and 5) reported that Esports is in its third year as an activity and that two new games have been added (FIFA & Madden) which should increase participation by schools/students even more.

#### **NMAA Activities Report:**

Ms. Dana Pappas, NMAA Commissioner of Officials, presented the Activities Report. She discussed three (3) items on her report: 1) provided information on the Activity Directors Q&A zoom sessions that have taken place throughout the Fall; 2) stated that a directory of all Activities Directors and activity sponsors has been compiled; and 3) reported that the Student Leadership Advisory Council has met twice this year with much of the group's focus placed on Mental Health Awareness.

#### **New Mexico Officials Association Report:**

Ms. Pappas presented the New Mexico Officials Association Report. She discussed four (4) items on her report: 1) stated that Volleyball officials held numerous virtual meetings throughout the fall with over 85% of officials in attendance over the past four months, with Basketball officials set to start the same thing at the end of the month; 2) reported that the NMOA is working on a historical directory of post season officials for past championship events; and 3) provided information from the NMOA Executive Board Meeting, which took place in October; and 4) reported on the formation of two new NMOA committees (Diversity and Inclusion Panel and Constitutional Review Committee).

#### **Discussion/Information Items:**

NMSBA: Scholastic Eligibility Inquiry - Ms. Marquez discussed the New Mexico state statute pertaining to the scholastic eligibility of students for participation in extra-curricular activities and the history of NMAA bylaws regarding this topic. A September Policy Services Advisory from the

New Mexico School Boards Association has raised questions regarding the interpretation of the statute and NMAA bylaws. The group asked for clarification regarding the matter and asked that correspondence be sent out from the NMAA to member schools regarding the matter.

Classification & Alignment for 2022-2024 - Ms. Marquez discussed Classification & Alignment for the next two-year block (2022-2024) and reported that enrollment numbers for 2020-2021 could be lower statewide due to the effects of the pandemic. Feedback included freezing the current breakdown of schools for one to two more years and collecting 40-day counts from 2020-2021 to get preliminary information on how this year may impact enrollment numbers for future classification purposes. The NMAA staff will conduct more research on this topic for discussion at a future meeting.

Game/Event Limitations for 2020-2021 - Ms. Marquez discussed the possibility of adjusting the game/event limitations for all sports for the 2020-2021 school year due to possible issues with club and high school sport seasons occurring simultaneously. The topic will continue to be discussed as future action may be needed.

Approval of NMAA 990 for 2019-2020 - Ms. Shari Kessler-Schwaner, NMAA Business Manager, presented a proposal to approve the NMAA 990 for 2019-2020. Mr. Parks asked for a motion to accept the proposal as presented. Ms. Dodd made the motion to accept proposal. Mr. Trujillo seconded the motion. (The cumulative provision cannot be used for middle school/junior high Students.) Mr. Parks asked for a motion to accept the proposal as presented. Mr. Carpenter made the motion to approve the proposal. Mr. Moyer seconded the motion. A roll call vote was taken and passed unanimously (12-0).

#### Proposal:

On an emergency and temporary basis for the 2020-2021 school year and due to the coronavirus pandemic, consider adding the following to Number 7 within the NMAA Handbook Addendum for COVID-19:

New Mexico students who transfer and participate in interscholastic athletics at an out-of-state school during the 2020-2021 school year shall not be subject to transfer penalties during the 2021-2022 school year provided those students return to their initial school.

Students who choose to remain out of state and participate in interscholastic athletics during the 2021-2022 school year shall not be provided this exception.

\*Note: NMAA bylaw 6.13.1.B shall remain in effect and students who start a season out of state shall not be eligible to return to New Mexico and participate in that same sport during the same school year.

#### Rationale:

The rationale for the transfer penalty cannot be upheld when interscholastic sports in New Mexico cannot be guaranteed for the 2020-2021 school year. In normal circumstances, transfer penalties are vital to the fair and just regulation of interscholastic athletics. Transfer penalties help create a level playing field and minimize both undue influence and displacement. However, without a guarantee that interscholastic sports will be offered in New Mexico during the 2020-2021 school year, it would be unduly harsh to hold students accountable for pursuing the opportunity to participate in states where interscholastic sports are offered.

Adjust the contest limitations for Fall & Winter sports as listed in the 2020-2021 NMAA Modified Master Table of Athletic Events. The changes reflect the condensed seasons proposed within the new sports calendar based on a February 22<sup>nd</sup> return to athletics.
