#### Proposal:

Consider adjustment of NMAA bylaw 4.1.2.B for 2018-2020 Classification & Alignment.

Currently Reads: A multiplier of 1.3 will be applied to all private/boarding schools, except in the sport of football.

ADD:

Exception: Boarding Schools that provide written notice to the NMAA that they will not use Bylaw 6.7.7 to obtain eligibility for its students will not be subject to the 1.3 multiplier.
