### **NEW Bylaw 7.15.1.M – Film Requirement**

This proposal would require that football coaches submit film to the NMAA/NMOA Hudl account for every varsity football contest.

#### Proposal:

School

Coaches are required to submit game film to the NMAA/NMOA Football Hudl account for each varsity contest. Film can be raw game footage and need not be clipped. Deadlines for submission after each contest are:

- Thursday games film must be submitted by 1:00 p.m. on Saturday
- Friday games film must be submitted by 1:00 p.m. on Saturday

Saturday games – film must be submitted by 10:00 a.m. on Sunday

Coaches can use the platform to exchange film between one another if they so choose, but the intent of the account is for internal use by the NMAA/NMOA staff and officials.

**Rationale:** The purpose of the film submission is to provide an avenue for the evaluation of officials and for the continued training and education of the NMOA football staff. All NMAA varsity head football coaches will be given Hudl account access via the NMAA License. These accounts will thus not create a financial burden on the individual schools/coaches because they provide basic access for film submission/exchange.

## Bylaw 7.14.2.C - Cross Country District & Pre-State Meet

This proposal would amend cross country bylaws pertaining to the maximum number of runners that can participate in the traditional "Pre-State Meet/Jamboree".

**Current:** Teams are allowed to enter a maximum of nine (9) runners in the District Meet (only). At all other varsity meets, teams are limited to seven (7) runners.

**Proposal:** Teams are allowed to enter a maximum of nine (9) runners in the Pre-State and District Meet (only). At all other varsity meets, teams are limited to seven (7) runners.

**Rationale:** The bylaw change will allow varsity teams to enter two (2) additional runners at the Pre-State varsity meet/jamboree. This will ensure that a school's potential alternate runners have the opportunity to compete on the course used for the championships prior to the actual state meet.
